OPEN TENDER NOTICE

A. S. College, Deoghar(Jharkhand) invites open tender in the form of sealed Technical & Commercial Bids for supply, installation and commissioning of Projectors and Projector Screens as per the attached specification and will be installed at A.S. College, Deoghar(Jharkhand), The Tenderer has to quote the price along with the installation and commissioning costs in the financial bid.

Complete set of Bid Documents may be downloaded from A. S. College, Deoghar (Jharkhand) website www.ascollegedeoghar.com from 29.03.2022.

Interested and eligible Bidders are required to submit the Technical and Commercial Bids in two separate sealed envelopes. The Technical and Commercial Bids should be accompanied by a bid security as specified in this Bid Document. The EMD in the form of Demand Draft of INR Rs. 60,000 / - drawn in favour of Principal, A. S. College, Deoghar (Jharkhand) payable at Deoghar should be enclosed in the same envelope containing the Technical Bid. The Technical and Commercial Bids mentioning the name and address of the bidder, tender enquiry number, due date of submission of tender must be delivered to **the Office of Principal, A. S. College, Deoghar (Jharkhand) on or before 06.04.2022 (up to 2:00 P.M.).**

The envelope containing the Technical Bid and the Bid Security will be opened at the office of Principal, A.S. College, Deoghar (Jharkhand), on specified Date & time in the presence of Bidders or their authorized representatives. In the event of the date specified for bid receipt and opening, being declared as a holiday, the due date for submission and opening of bids will be the following working day at the appointed times.

GENERAL TERMS AND CONDITIONS: -

1. **Cost of Tender Document:** The cost of Tender Document is Rs. 5,000. /- in the form of D.D. drawn in favour of “The Principal, A.S. College, Deoghar (Jharkhand) payable at Deoghar. Tender without cost of tender document would be rejected.
2. **Two Bid System:** The original copy of tender (duly signed) should be sent to the Office in a sealed cover in a double envelop. The tenderer must place the two sealed envelopes clearly marked „TECHNICAL BID“ and „FINANCIAL BID by indicating the Draft number, date & amount of EMD on the envelope of „TECHNICAL BID“ failing which the tender will not be opened. Financial Bid to indicate a warning “*DO NOT OPEN WITH THE TECHNICAL BID*”. The outer cover should be superscripted **Tender for “For Supply, Installation & Commissioning of Projectors and Projector Screens at A.S. College, Deoghar (Jharkhand)”**.
3. **Downloads :** Tender Document with full details can be downloaded from college website: www.ascollegedeoghar.com from 29/03/2022 participation in the tender will be subject to remittance of the prescribed **Cost of tender document & EMD** along with the **Technical Bid**.
4. **EMD:** EMD of Rs. 60,000/- in the form of crossed Demand Draft/ Bank Guarantee drawn from any commercial bank IN FAVOR OF “The Principal, A.S. College, Deoghar (Jharkhand)” payable at Deoghar should be enclosed with the tender (technical bid) of each quoted by the bidder(s). The Unsuccessful Bidder’s EMD will be returned soon after the finalization of Tender, whereas the Successful Bidder’s **EMD** will be returned subject to furnishing of the required **Performance Security**. No interest will be paid on EMD for the period of retention in the college. Tenders without EMD would be rejected.
5. **Security Deposit:** The successful bidder has to furnish an amount equivalent to **ten (10) per cent** of the order expected value as **Performance Security Deposit** which will be refunded/ returned only after satisfactory completion of the contractual obligation including warranty. The Security Deposit should be in the form of Demand Draft, Fixed Deposit Receipt or Bank Guarantee from any commercial bank and on which no interest will be paid.
3. **Warranty:** The supply of goods should be of tender warranty for three year including all parts in this schedule from the date of supply and acceptance by the concerned authority However, the manufacturer’s guarantee if any which exceeds, should be extended accordingly. After Warranty period Annual Maintenance Charge (AMC) should be quoted for 01 additional year on yearly renewable.

4. A penalty will be imposed if the after-sales service of the vendor is not satisfactory during the warranty/AMC period. The following points will be marked as Unsatisfactory After Sales Service, if:

- I. A Call is not attended within 24 hours of the Call given two times **within 30 days**.
- II. Any installed equipment/accessories are down for more than 24 hours after logging a service call
- III. Technical incompetence of the Service Personnel.
- IV. Improper/illegitimate activities by the Service Personnel
- V. Replacement of installed equipment/s or accessories took more than the specified time frame.
- VI. Failure to perform preventive maintenance and submission of the report.

15. A penalty will be imposed if the after Sales Service of the bidder is not satisfactory. The penalty rate for non-functioning of each classroom is as follows:

Working office hours only shall be accounted for the imposition of penalty.

1. **Due Date:** Tenders received after due date and time will not be considered. College will not be responsible for postal delays.
2. **Payment:** No advance payment is permissible. Payment would be made after successful completion of work and duly certified by the officer of the university designated for the purpose.
3. **Place of Delivery:** A. S. College, Deoghar (Jharkhand) or as per the instruction of the College.

4. **Liquidate Damage :** In case, the firm fails to supply the material as specified in the purchase order, a sum of equivalent to **0.5%** of the contract price per week or part thereof (delay until actual implementation or performance) shall be deducted from the bill up to a maximum deduction of **10%** of the contract price. Once the maximum is reached, A. S. College, Deoghar (Jharkhand) may consider termination of the contract.
5. **Bank details for e-payment:** The bank details may be furnished along with tender for making e-payment to the successful bidder.
6. **Period of Validity:** The rates quoted shall be valid for a minimum period of 180 days beyond the date of opening of tenders.
7. **Evaluation:** The Technical Bids are to be opened by the B.O.G., RUSA Cell, A. S. College, Deoghar in the first instance and will be evaluated technically by the B.O.G., RUSA Cell, At the second stage Financial Bids will be opened only for the technically qualified tenders for further evaluation before awarding the contract.
8. **Rejection of tenders:** Tenders not complying with the above conditions are liable to be rejected.
9. **Acceptance of tender and Jurisdiction:** The Principal, A.S. College, Deoghar (Jharkhand) reserves the right to accept or reject any of the tenders either in part or in full without assigning any reason thereof. Decision of the Principal. will be final and legally binding.
10. **Laws Governing the Contract & Jurisdiction:** The contract shall be governed by the laws in force in India. In the event of any dispute arising out of the tender, such dispute would be subject to the jurisdiction of the Civil Court within the city of Deoghar only.
11. The authority inviting tender may, for any reason may modify the bidding documents by an amendment. To provide reasonable time to take the amendment into account in preparing the bid, the authority inviting tender, may at his discretion, extend the date and time for submission of bids. The Principal, A.S. College, Deoghar (Jharkhand) reserves the right to cancel the tender process without assigning any reason whatsoever, at any stage.
12. **Specifications** are the basic essence of the product (Both foreign & indigenous): It must be ensured that the offers are strict as per our specifications. At the same time, it must also be kept in mind that merely copying our specifications in their quotation shall not make firms eligible for consideration. A quotation has to be supported with the printed technical leaflet/literature (wherever applicable) and the specifications mentioned in the quotation must be reflected/ supported by such printed technical leaflet/literature model quoted/tendered specifications should invariably be highlighted in the leaflet/literature

for easy reference. The technical specification should be verifiable through the official website of the OEM. The B.O.G., RUSA Cell may call for a technical presentation to the bidder if required.

13. Reasonability of Rates/ Firm Price

- I. The bidder shall certify that the rates quoted are the lowest for any institution in the country and not higher than the MRP/prevaling market rate.
- II. During the period of the contract, if the price of any tendered item is reduced due to any reason including any Law or Act of the Central/State Government, the bidder shall be statutorily bound to intimate the reduced rates immediately to the purchaser and shall charge the reduced rates. The purchaser is empowered to unilaterally effect such reduction as is necessary in rates, in case the bidder fails to notify or fail to agree to such reduction of rates.
- III. Subject to the condition stipulated above, the prices shall remain firm for the validity period of tender and on no account any price increase shall be entertained till completion of the tender validity period.
- IV. No bidder will be allowed at any time on any ground whatsoever, to claim revision of or modification in the rates quoted by him. The representation of the bidder that computation/ typographical or clerical error etc. has been committed in the bid and request for reversion on such plea shall not be entertained after the opening of the bid.

14. Force Majeure: The above condition of the delivery period, price reduction & termination, etc. are subject to Force Majeure conditions that are beyond the control of the supplier, do not involve fault or negligence of the supplier, and are not anticipated. Such events may include but are not limited to riots, mutinies, war, fire, storm, tempest, flood, epidemics, or other exceptional causes like quarantine restrictions, freight embargoes. On specific requests made by the bidder, the time period of supply may be extended by the purchaser at his discretion for such period as may be considered reasonable. However, the condition shall not include scarcity of raw materials, labour dispute, failure of sub-vendor, and increase in the cost of raw material.

15. Saving Clause: No suit, prosecution, or any legal proceedings shall lie against Tender Inviting Authority or any person for anything that is done in good faith or intended to be done in pursuance of tender.

Eligibility Criteria to Bidders

The Bidding is open to all qualified Bidder who fully meet the following qualifying requirements: -

1. The bidder should be an OEM (Original Equipment Manufacturer) or their Authorized partner. In case of authorized partner, a letter of authorization from original manufacturer must be furnished. (Submit self-attested documents)
2. The bidder should have executed orders for supply of similar Electronic goods/ IT enabled Items in Govt. (State/ Central), PSUs during last 03 (three) years. (Submit self-attested document)
3. The bidder should have an average annual turnover of not less than 1 (one) crore in the last three financial years and must submit an attested photocopy of the audited balance sheet & ITR of last 03 (three) years as a proof of annual turnover stated.
4. The Bidder should have Jharkhand GST registration. The Latest Jharkhand GST Certificate should be submitted. (submit self- attested documents)
5. Bidder should have local office & service support in Jharkhand preferably at place of supply i.e. Deoghar & ISO Certification is desirable. (submit self- attested documents)
6. Bidder must submit a copy of PAN Card.
7. Bidder must not have been blacklisted by any PSU's/Central or State Government / Court of Law. (submit Affidavit)
8. The manufacturer must have the experience and expertise in undertaking major projects of installing the similar brand hardware and software with government organizations with multiple locations in India.
9. The Tender must quote all items of requirement list & must have capability of executing entire work on Turnkey basis.
10. The bidder must be registered on the PFMS Portal under the CAG, Ministry of Expenditure, Government of India

Instruction to Bidders

1. The Supply, Installation and Commissioning of Projectors and Projector Screens will be done in Classrooms at A.S. College, Deoghar (Jharkhand),
2. The bidders will have to quote the price along with their installation charges in the financial bid and the cumulative price shall be taken into consideration.
3. The Supply, Installation and Commissioning schedule shall be within 60 days from the date of issuing of work order at the location as mentioned in the tender and should be tested by the individually.

4. In case of any discrepancy between rates mentioned in figures and words, the offer in word shall prevail. If there is any discrepancy between the unit price and the total, the unit price shall prevail and the total price shall be corrected.
5. The bidder whose tender is accepted has to supply the items within the stipulated Period as mentioned. After successful installation the technical support will be provided by bidder company's/Authorized partner as and when required for duration of 3 (three) years. A. S. College, Deoghar (Jharkhand) may forfeit the EMD amount deposited if the bidder fails to supply all the items in stipulated period as mentioned above.
6. The EMD number of unsuccessful Bidders will be refunded/ returned without interest after completion of tender formalities.
7. The price bid shall be evaluated on L1 basis as well as on Turnkey basis also.
8. No representation for change of rate once accepted will be considered.
9. If the items supplied by the accepted bidder are not as per the specified model and specification, the B.O.G., RUSA Cell, A. S. College, Deoghar reserves the right to reject them.
10. The tender should be submitted in two cover system i.e. **A:** Technical Bid along with and EMD and **B:** Price Bid. There should be proper indication of the contents on each envelope.
11. The Bidders shall seal the envelope No. 1 Technical envelope and envelope No. 2 Commercial envelope in separate inner envelopes, duly marking the envelopes as "envelop No.1, Technical Envelope" and "envelope No.2 Commercial Envelope". He shall then place these two envelopes in an outer envelope. Both the inner envelopes and the outer envelope should be addressed to: The Principal, A.S. College, Deoghar (Jharkhand), PIN-814112.
12. Any bid received by the Tendering Authority after the deadline for submission of bids prescribed by the Tendering Authority, will be rejected and / or returned unopened to the Bidder.
13. The Tendering Authority will award the work to the Successful bidder bid whose bid has been determined as the lowest evaluated bid provided further that the bidder is technically eligible.
14. Bidders are strictly advised to submit the Details of full specifications along with warranty period with technical bid.
15. 100% of the total price of the supplied items will be payable after submission of bill along with successful installation, satisfactory performance and physical verification certificates duly signed by concerned at location.

16. The supplier will have to assume onsite support of the supplied items.
17. During the onsite warranty period of 03 (Three) year the bidder shall have to rectify/change free of cost any hardware/software defect.
18. Bidder shall make available all the hardware/software needed to operationalize of all supplied items.
19. Training: Onsite free demonstration, operation, and maintenance training shall be provided.
20. Installation, commissioning and successful trial run shall be done at the different site locations/classrooms of the college by the supplier or their authorized agent.
21. Operation & Maintenance Manuals: Two sets of operation & maintenance manuals shall be supplied for each classroom.
22. Bidder shall also be responsible for the onsite maintenance free of cost for three year & AMC on expiry of term at the mentioned rate (The Bidder must specifically mention the AMC charges for the period of additional 04(four) years in the Bid).
23. All legal disputes are subject to the jurisdiction of Deoahar courts only.
